Applicant agrees and understands that the license, if granted, is for one location only and cannot be moved to another separate location, that it includes, incorporates and is to be interpreted be the laws of the State of Illinois, the resolutions of the County Board of Tazewell County, the lease, this application, and the circumstances surrounding the issuance of the license, and other factors, and that any license issued by the Liquor Control Commissioner contrary to the laws of the State of Illinois or the resolutions of the County Board of Tazewell County is void whether or not signed and delivered.
